YOUR FUNDRAISING can make a difference

By donating to Reach you are supporting the valuable work we offer to families of children with an upper limb difference.



- 19 Branch networks run by volunteers throughout the UK and Ireland to provide support and an opportunity for children and parents to meet.
- Head office providing information and support through telephone, email, print and social media helplines.
- 'Within Reach' magazine produced 3 times a year, full of information.
- Hire scheme for one-handed Recorders and a library of music for other instruments.
- Personal Accident Insurance cover for upper limbs. (UK residents from 2 to 85yrs)
- 'Try before you buy' loan scheme for useful equipment, such swim paddle, an array of scissors and other gadgets.
- Bursary Grants for members up to the age of 25yrs.
- Annual Reach Activity Week (RAW) residential for Reach children aged 10-18yrs.
- Family Activity Weekends across the UK.
- Annual Family Weekend and conference where we encourage sharing experiences and resources.
- Invitations to events and opportunities run by partner organisations such as Jubilee Sailing Trust, Douglas Bader Foundation Activity days
- Member's only Facebook group and What's App groups where you will be able to chat safely to other members. This is a really great way to get to know other parents and share concerns and developments.
- Links to a partnership coalition with other limb difference charities

Pays for a Welcome Information Pack for one family.

Is the cost of one workshop leader at a family weekend, to provide the children with fun and interesting activities.

FUNDRAISING IDEAS

We have plenty of great ideas to get you thinking plus all the tools you need to get your fundraising off to a flying start!

Get together with friends, family or work colleagues for a sponsored walk.

Sponsored Walk

Bake Off!



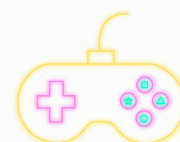
Do you love to cook? Why not host a charity dinner party? Put on a three-course feast for your friends. Then ask them to donate what they think the meal would cost in a restaurant.

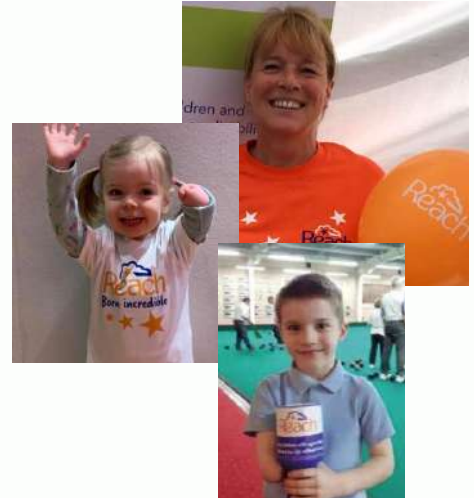
Fundraising for Reach

Matched Funding

Lots of companies in the UK operate Matched Funding schemes they will pledge a sum of money relating to the amount their employee has raised or donated to the charity of their choice.

Some organisations will match fund on a £ for £ basis, others will stipulate what they are prepared to give. Why not ask your employer if they can match your donation?

Free Money – Gift Aid!

Gift Aid is a great way to make every sponsor's donation worth 25% more.

You can increase the money you raise by simply getting people to fill in a Gift Aid declaration form. This enables us to claim tax back from the government and increases the overall benefit to Reach.

Each individual needs to be a tax payer and have paid more tax than the amount we reclaim from the government.

Each year babies are born in the UK missing part of one or both arms and hands, for a variety of congenital reasons. Every penny that is donated to Reach goes to ensuring that each child with an upper limb difference is able to meet with others, develop life long friendships, develop a positive sense of self worth and to live life without limits.

Please make sure you fill out each section in full and in the donor's own handwriting (forms in the same handwriting or printed won't be eligible for Gift Aid). Please make sure sponsors tick the Gift Aid box next to their address below if eligible. Please note we can't claim Gift Aid on business addresses or on multiple sponsors e.g. Mr & Mrs Smith.

Help us to make more by ticking the Gift Aid box
 Boost your donation by 25p for every £1 you donate. I want to Gift Aid my donation and any donations I make in the future or have in the past 4 years. Keeping it safe & legal

We are so grateful to you for fundraising for Reach and your safety and wellbeing is our priority. Please follow our fundraising guidelines and ensure you adhere to all laws and health and safety guidelines when organising and holding your event.

Collections can be a fun way to raise donations and awareness for us, but first consider these useful guidelines:



- For collecting on the street, you will need a licence from your local authority.
- For collecting outside a supermarket store, you will need permission from the manager.
- For collecting on private property you will need permission from the land owner.
- Leaving a collection tin in a shop, you will need permission from the owner

Returning your collection tin

When you have finished collecting, or if you no longer wish to collect for Reach please return the tin to:

Raffle guidelines

Holding a raffle is a great way to increase donations from your event.



Large scale raffle

If you are holding a large scale raffle you may need to obtain a small lotteries licence. You must not:

- Sell tickets on the street or house to house
- Anyone under the age of 16 may not sell or purchase tickets
- Tickets must state that the lottery is in aid of Reach Charity and include your name and address and date of the lottery draw.

Small raffle

If you hold a small raffle on the day of your event you do not have to get a special licence as long as:

- Any prizes purchased are worth a total of no more than £250. Donated prizes can be of unlimited value.
- All tickets are sold on the same day as the raffle is drawn.
- Tickets are sold for the same price and there are no discounts.
- Prizes that involve alcohol are only included if the event is being held on licenced premises.
- All tickets are sold on the same premises and on the same day as the raffle is drawn.

Online raffle

You will need a licence to run an online lottery/raffle to run it legally. You may want to consider other types of fundraising if you don't want to apply for a Gambling Commission licence.

Top Tips & Thank yous!

Our final 'Top Tips!'

- Make it fun whether it's a cupcake and coffee morning or a sponsored cycle, give people a good reason to get involved and have a good time doing it.
- Give yourself plenty of time to plan and get some help along the way. Speak to the local Reach branch co-ordinator to see if you can draft in some additional support.
- Contact your local press and local news websites to help with the publicity.
- If you're organising a big event, book your venue early and ask for a charity rate. You might get a discount.
- Use social media to help spread the word.
